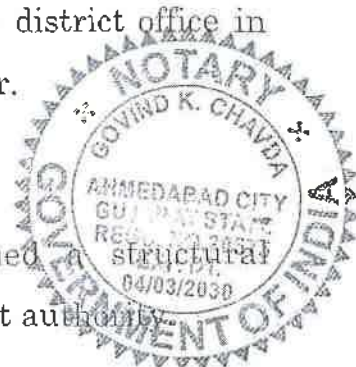

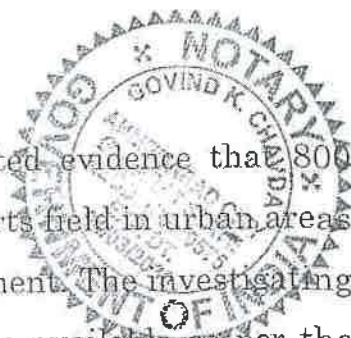

VI) The teacher – student be as per the rules. The area of the class room in the school should be as per the rules and should have all the necessary physical facilities.

VII) Under sub – section (1) of section 24 of the Act the teacher should do his duty.

VIII) Teachers themselves will not be able to provide private tuition it will be the responsibility of the governing body to see that.

IX) A transparent and fair admission process will have to be followed by following the guide lines and orders issued by the central government or the state government or the director.

9. The school will have to provide education according to the curriculum prepared on the basis of the curriculum formulated by the appropriate authority.

Conditions of school accreditation :-

The school board will be responsible for fulfilling and maintaining the conditions of the school's accreditation.

2. The school board shall be responsible for complying with and implementing all the provisions of the right of children to free and compulsory education Act 2009 and the right of children to free and compulsory education rules 2012 and the Mumbai primary education Act 1947 and the Mumbai primary education rules 1949.
3. In addition to the Act and the rules framed there under, the school board shall be responsible for complying with the rules bye – laws, resolutions, circulars, instructions etc promulgated by the state govt. from time to time.
4. The school admit children from weaker sections and disadvantaged groups in the nearby area in Std. 1 at the rate of 25% of the strength of that standard. And free and compulsory elementary education should be provided until its completion. The concerned office will have to be contacted for its implementation.
5. Capitation fees are prohibited and therefore the trust board or the school shall not accept any capitation fees or other donations or items in exchange for such fees.

6. He school does not have to undergo any screening test or procedure on the child or his or her parents or guardians for the purpose of admission.

7. The school shall not deny admission to any child on the basis of lack of proof of age or on the basis of religion, caste, creed or gender, place of birth or any of them.

8. The school should ensure that,

I) No child admitted to the school shall be detained in any class other than class 5 and 8 until the completion of his/her elementary education or not to be expelled from the school or be subject to the prevailing rules of class promotion.

II) No child shall be subjected to physical punishment or mental torture.

III) Every child who completes elementary education shall be awarded a certificate as prescribed under rule – 30.

VII) Under sub – section (1) of section 24 of the Act, the teacher should do his duty.

VIII) Teachers themselves will not be able to provide private tuition it will be the responsibility of the governing body to see that.

IX) A transparent and fair admission process will have to be followed by following the guide lines and orders issued by the central government or the state government or the director.

9. The school will have to provide education according to the curriculum prepared on the basis of the curriculum formulated by the appropriate authority.

10. The school should admit students in proportion to the facilities available in the school as stipulated in section 19 of the act.

27. Records, statistical reports and certificates provided by school principles or administrators must be reliable.

28. 32. After the school gets its accreditation, all the children studying in the school will have to be regularly entered in the "Aadhar Dias child tacking system" managed by the Vidya Samiksha Kendra. Also, regular attendance of all students studying in the school will be mandatory.

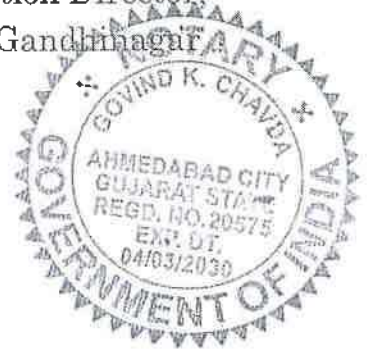

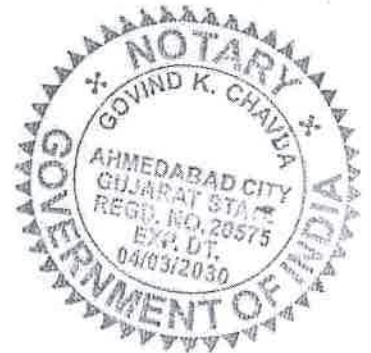
